

## 職員編制 Staffing

註冊社工、護士、復康工作員、廚務總管、清潔總管、復康助理及活動助理等  
Registered social workers, nurses, rehabilitation workers, rehabilitation assistants, programme assistants, etc.

## 申請條件 Eligibility Criteria

- ★ 年齡在15歲或以上，男女均可
- ★ 精神狀況穩定的精神病康復者，須具備基本的自我照顧能力
- ★ 願意接受訓練及參與群體生活
- ★ 身體健康及無傳染病
- ★ 無酗酒、濫用藥物或嗜賭等習慣
- ★ Aged 15 or above, male or female
- ★ Person in recovery with mentally stable, capable for self-care ability
- ★ Willing to receive training and participate in groups and community life
- ★ Physically healthy and no infectious diseases
- ★ Not addicted to alcohol, drugs or gambling

## 服務期限 Length of Stay

按個別需要由半年至兩年不等  
Half a year to two years depends on individual needs



## 申請程序 Application Procedures

- ★ 必須經社工轉介往社會福利署「康復服務中央轉介系統」輪候
- ★ 被接受申請者會進行面試及評估，如有需要會再安排約見本會指定的精神科醫生作評估
- ★ 申請結果會透過書面經轉介人通知申請者
- ★ Applicants are referred by social worker and enrolled in Central Referral System for Rehabilitation Services of Social Welfare Department
- ★ Applicants will be required to have assessment before admission and to be further assessed by Agency's psychiatrist if necessary
- ★ Applicants will be notified the result in writing through the referrer



## 收費 Fees

## 離舍及退出服務

### Discharge or Withdrawal from Service

所有服務使用者將按其復康進度而訂立其離舍計劃。服務使用者可主動提出退出服務。惟須與主診醫生、醫務社工、家人及宿舍職員商討及須辦理有關的手續。  
Discharge plan will be formulated according to service users' progress. Service users can make a request to leave the service upon the discussion with the case medical officer, medical social worker, family members and house staff with proper procedures.



## 終止服務 Termination of Service

在以下情況，服務使用者會被終止服務：

- ★ 經評估為未能在服務中獲益
- ★ 嚴重破壞舍規，影響其他服務使用者生活或宿舍運作
- ★ 病逝、身故、長期失蹤（超過一個月）
- ★ 因復發或因病需長期留院超過一個月，而醫院方面未能確定出院時間

Service will be terminated under the following circumstances:

- ★ For service users who cannot benefit from the service after assessment
- ★ For service users who violate the house regulations
- ★ Deceased or lost trace (over one month)
- ★ Hospitalized without definite discharge schedule

- To facilitate service users to adapt independent living with developing their strengths and providing living skills training.

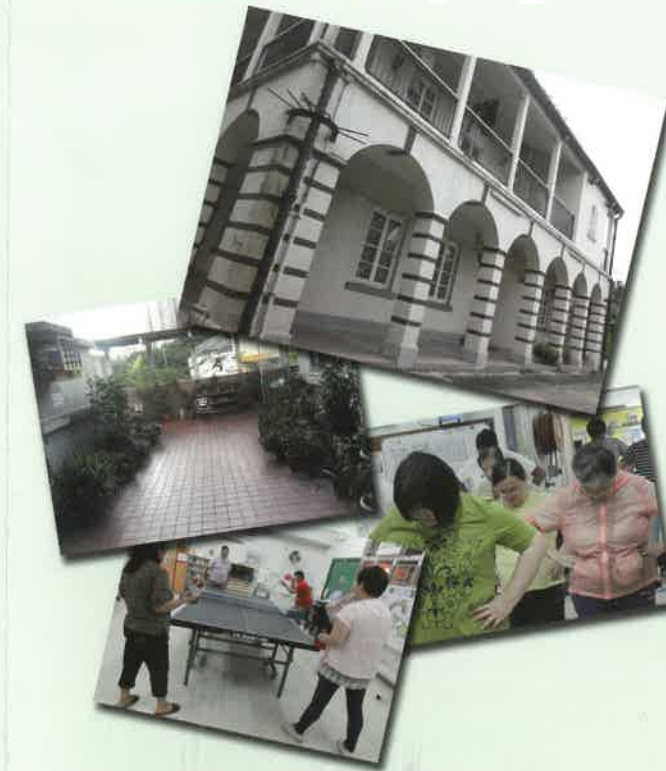
### 服務範圍 Services
